3. Background:

NIPER-Hajipur started functioning in 2007 under the mentorship of Rajendra Memorial Research Institute of Medical Sciences (RMRIMS), Patna till 31.10.2018. Its own first Director assumed charges with effect from 01.11.2018, and the Institution is now under infused with zeal and vigour in achieving centre of excellence for higher education, research and development in pharmaceutical sciences, conceived to provide leadership quality in pharmaceutical sciences and other related areas. It imparts education in Five (05) specializations, namely (i) M.S. in Biotechnology, (ii) M.S. in Pharmacy Practice and (iii) M. S. in Pharmacology & Toxicology (iv) M.S. in Pharmaceutical Analysis (From 2021-22) and (v) Pharmaceutics (From 2021-22).

Government of Bihar has allotted a place of land measuring area of 12.43 Acre in EPIP campus Industrial area Hajipur for the setting of the Permanent campus. The Institute is under the process of the signing of the MoU with CPWD for the execution of the Construction of the Permanent campus at allotted land.

Due to the limited technical expertise in the area of architectural and civil aspect the Institute wants to hire a reputed and experienced firm/ Individuals for the consultancy services for taking the inputs to finalize the various plans / documents submitted by the CPWD for the execution of the project.

4. Scope of Work:

The Architect is required to provide services in respect of the following:

- 4.1 Site evaluation and assessment
- 4.2 Preparation of DPR,
- 4.3 Preparation of Detailed architectural working drawings for execution,
- 4.4 Preparation of Detailed structural design and drawing for actual execution,
- 4.5 Preparation of layouts, Interior Designing including Electrification, HVAC, Acoustic Control, Sanitary & Plumbing and other related Works
- 4.6 Preparation of Interior design and space planning.
- 4.7 Preparation of Preparation of Detailed Bill of Quantities and specifications and Estimate of cost.
- 4.8 Preparation of Design of fixed items of work, loose furniture & interior related civil works.



- 4.9 Preparation of Illumination design.
- 4.10 Preparation of Acoustic, Air Conditioning and Fire Detection & Fighting design.
- 4.11 Preparation of Graphic design and signage.
- 4.12 Preparation of Indoor plants scape.
- 4.13 Finalization of Selection of materials, equipment and other interior related elements.
- 4.14 Integration of all Engineering services.
- 4.15 Periodic inspection and evaluation of works at site.

6.2 Documents to be Submitted:

1. Full details of the Proprietorship Firm / Partnership Firm / Public or Private Limited Company.
2. Documents like Photocopies of COA Registration Certificate, APWD registration, PAN Card, GST Registration Certificates, Last 3 Years IT Return (for the group of Companies wherever applicable), Partnership Deed (in case of Partnership Firm), Registration Certificate and Memorandum of Association (for Private Limited or Limited Companies).
3. In all the cases above all the proprietors/partners/directors of different kind of Organisations must be Registered with Council of Architecture, New Delhi, India.



4. The Applicant should have proper Presence in Guwahati in form of his own Registered Office.
5. Power of Attorney of the person to sign this Tender Documents.
6. Work order of 05 nos similar projects of project cost not less than of Rs 10 Cr., or 03 nos similar projects of project cost not less than of Rs 25 Cr in last 05 years.

6.3 Commercial Bid

1. The rate quoted shall be in % percentage of the project cost.
2. The rate shall include cost of 3 dimensional views, CAD drawings, presentation drawings, etc as required to finalize the various requirement submitted by CPWD to the Institute.
3. GST and other applicable taxes (if any) shall be paid as extra as per the prevailing Government norms and rules.

6.4 Submission Process

1. Interested applicant may furnish their expression of interest (EoI) in 02 (two) separate envelopes, one containing the commercial bid superscribing “commercial bid” and the second containing the technical bid superscribing “ technical bid” and both the envelope should be sealed inside a third envelope super scribing “Expression of Interest (EoI) for Selection of Architects/Architectural Firms for Providing Comprehensive Architectural Services for the finalization of façade and interior decoration of Administration and Auditorium space around 1000 sq.m. architectural drawings for execution to be submitted to CPWD for Construction of Permanent Campus of National Institute of Pharmaceuticals Education and Research (NIPER), Hajipur.

2. The EoI submitted by the applicant shall remain valid for a period of 90 days after the closing date (deadline) for submission of EoI prescribed in this document. EoI valid for shorter period may be rejected as non-responsive. The Employer may solicit the applicants consent to an extension of EoI validity (but without the modification in their EoI).

3. The Tender Inviting Authority reserves the right to withdraw this EoI, if he/she determines that such action is in the best interest of the Government of Assam. The Employer undertakes that all the information shared by the applicant will be held in strict confidence and will not be made public unless directed by court of law.



6.5: Disqualification

1. The Tender Inviting Authority may at its sole discretion and at any time during the evaluation of EoI, disqualify any applicant, if the applicant Submitted the EoI after the response deadline, made misleading or false representations in the forms, statements and attachments submitted in proof of the eligibility requirements;
2. Exhibited a record of poor performance such as abandoning works, not properly completing the contractual obligations, inordinately delaying completion or financial failures, etc. in any project in the preceding three years;
3. Submitted a EoI that is not accompanied by required documentation or is non-responsive;
4. Failed to provide clarifications related thereto, when sought; (vi) submitted more than one EoI;
5. Was declared ineligible/blacklisted by the Government of India/State/UT Government;
6. Should not be in litigation with any Government in India.

6.6 Confidentiality

Information relating to the examination, clarification, comparison and evaluation of the EoI submitted shall not be disclosed to any of the responding applicants or their representatives or to any other persons not officially concerned with such process until the evaluation process is complete.
