## NOTICE TO GUARDIANS / PARENTS

**Subject:** Continued agitation and strike by your ward to an extent of taking the Institution building in their custody – creating law and order situation.

Sir/Madam,

You are aware that Institute Building is also a place for academic & research activities. It also houses Boys hostel. The girl students are provided accommodation in the RMRIMS hostel who are to be shifted to Hajipur. The institute had issued a Notice to vacate the existing hostel and keep their belonging in one room each for Boys and Girls in the building for routine repair and maintenance. But when the students expressed orally their difficulty in getting train tickets to their native place by some and some said that they do not want to go now, the administration said that they can stay back but have to co-operate for the said works, which they agreed but later on went for agitation and strike; and rest you must knowing it.

The institute wanted to know the students who would want hostel facilities for the AY 2019-20 and gave the ready to fill application form, which the students refused to take. Now, the students are not letting the Housekeeping staff, Security Guard or NIPER Staff enter the premises for work, (copy enclosed). Both girls and boys are in the building, locking the Institute main grill gate from inside. Hence, the Institution is forced to take District Administration help to restore law and order for which, the Institute will not be held responsible for any consequences arising out of this.

You are requested to talk to your ward in this regard to withdrawal of such extreme stand by them in bringing normalcy in the functioning of the Institute.
