**Agenda:**

**1. Quorum of the Meeting**

The Quorum of the meeting was maintained.

**2. Introduction of New Course - Pharmaceutics and Pharmaceutical Analysis**

The NIPER Hajipur proposed that the new course in Pharmaceutics and Pharmaceutical Analysis to be inducted during the Academic year 2020-2021 with intake of 10 seats each.

**Resolution:**

The agenda was discussed and approved to start the new course in Pharmaceutics and Pharmaceutical Analysis during the Academic Year 2020-2021 with intake of 10 seats for each department.

He emphasized on Interdisciplinary Department research and research on neglected diseases like leishmaniasis.

- 5. Establishment of animal house, Pharmacology Lab, BSL-2 facility and purchase of Instruments**

**Resolution:**

The Committee noted and approved the construction of the Animal House, Pharmacology Laboratory set up, BSL-2 Lab Facility and Purchase of new instrument.

**6. Any other**

Dr. USN Murty emphasized to bring extramural fund by all faculties. For Pharmacy Practice department he suggested to work in community pharmacy and generic drugs. A small clinical centre is also proposed. Dr. Prabhakaran suggested about academia industry collaboration and bringing new funds. Dr. Ravishankar and Dr. N.R. Biswas stressed about the need of more faculties at NIPER-Hajipur. Director, NIPER-Hajipur apprised to the committee that interview for regular position is going on and within 2 to 3 months more faculties will join the institute. Dr. N.R. Biswas agreed to provide in activated samples of COVID-19 patients for research on biosensor based work at NIPER-Hajipur. Dr. Om Kumar and Dr. Satish Bishe advised to work on therapeutic drug monitoring (TDM), antibiotic resistance and drug repurposing against Visceral Leishmaniasis

in future. Dr. Bishe also suggested that a possible collaboration with ZYDUS-CADILA can be made for development of vaccines against VL.  
The Director, NIPER-Hajipur suggested about Inter-NIPER collaborations based on respective research domain
