The 2nd Academic, Planning and Development Committee (APDC) meeting was held on 18.03.2021 at 4:00 P.M through Video Conferencing under the Chairmanship of Dr. U.S.N. Marty. With the permission of the Chairman the meeting was started to transact the following agenda.

Quorum of the Meeting

The Quorum of the meeting was maintained.

Agenda:

- 1. Biosimilar course introduction at Masters level at NIPER-Hajipur.
- 2. Modification of existing syllabus in biotechnology at Master's Level

Resolution – Inclusion of Biosimilar course was approved with 75% of existing Biotechnology and 25% of Biosimilar course. A presentation was given by Dr. Satish Bhise highlighting the importance of Biosimilars at Masters Level. It was also decided

that at least 6-9 students of Biotechnology batch 2020-22 will do their entire project in an affiliated Industry related to Biosimilar/ Biologics in India.

3. Status of Project Progress of PG-II year (Biotechnology, Pharmacy Practice & Pharmacology & Toxicology)

Resolution – Current status was shared with the list of existing and outside faculties. All faculties were advised to routinely check the status of students doing project outside the Institute.

4. Placement Planning for Passing Batch in June, 2021

Resolution – The committee pointed that apart from Industry, academic jobs (project assistant, SRF etc.) should be created among NIPERs.

5. Any other

- Dr. USN Murty emphasized to bring extramural fund by all faculties. For Pharmacy Practice department he suggested to do project work in Hospitals. The Chairman recommended establishing PG discipline in pharmaceutics and Pharmaceutical analysis from 2021 academic session on words.
- Dr. Prabhakaran and Dr. Ravishankar appreciated the idea of Biosimilar course which is industry oriented. Dr. Om Kumar and Dr. N.R. Biswas ensured that their Institute will provide all kind of help for development of NIPER-Hajipur.
- The Director, NIPER-Hajipur confirmed that many initial steps (discussion with Industry, design of course curriculum, introduction of faculty from industry for teaching of biosimilar course etc.) are already in process. Hence the Biosimilar course can be integrated with Biotechnology department from the academic year 2021-22.
