### Advertisement for direct admission to Ph.D. programme

The National Institute of Pharmaceutical Education and Research (NIPER) is the first Institute of its kind to be set up at in the State of Bihar in the year 2007. It is an autonomous institution of national importance, established under the aegis of Department of Pharmaceuticals, Ministry of Chemicals and Fertilizers, Govt. of India under NIPER Act 1998 at Hajipur in Vaishali District of Bihar. It is a centre of excellence for higher education, research and development in pharmaceutical sciences, conceived to provide leadership in pharmaceutical sciences and other related areas.

NIPER-Hajipur is inviting applications for direct Ph.D. admission for candidates having their own fellowship from CSIR-UGC NET (NET-LS not eligible)/DBT-JRF examination ('A'category only)/DST-INSPIRE Fellowships/ICMR-JRF examination (those selected for working only in ICMR projects are not eligible) are eligible to apply. Admission of candidates having DST-INSPIRE fellowship shall stand cancelled in case candidate fails to obtain fellowship from DST. NIPER will not provide any fellowship to such candidates from its funds, however the student can claim from the original funding agency which selected them for fellowship. Please note that valid proofs of clearing the fellowship examinations are mandatoryfor appearing in the interview. The candidate should have good academic background in respective discipline and he/she should be self motivated with an independent, target-oriented and systematic working style. A high degree of creativity and flexibility as well as excellent collaborative skills are desirable. No TA/DA or any other expenses will be paid for appearing in the interview.

### Eligibility Criteria

- Master's degree (M. Sc./M. Tech/M.S Pharm/M. Pharm.)/MBBS in any branch of Life Sciences/Biotechnology/Chemistry or allied subjects with a special interest in drug discovery and development.
- Candidates should also have obtained at least 60% (or equivalent in CGPA of 6.75 out of 10) in the above examination and their 12<sup>th</sup> standard board examination. The criteria will be 55% for SC/ST/OBC (non-creamy)candidates.
- Appearing candidates or those awaiting results for the highest qualifying examinations can also apply. Such candidates should be eligible in all aspects at the time of admission.
- Master in science/M. Tech./MS Pharm/M. Pharm/MBBS candidates should hold CSIR-UGC(JRF)/ DBT(JRF)/ ICMR-JRF/ DST-INSPIRE or equivalent.
- For Master's degree holders, GATE/GPAT is NOT a valid fellowship.
- The JGEEBILS/TIFR/IISc and similar entrance examinations are NOT valid fellowship examinations for NIPER-Hajipur.
- Terms and conditions, fellowship amount, etc. will be governed by the awarding agency and further subject to the rules and conventions of the Institute.

#### Age Limit

The upper age limit is 28 years which is relaxable for SC/ST/OBC (non-creamy)/Physically Handicapped/ Women candidates.

**Application Procedure:** Interested candidates who meet the above criteria can directly sent their CV via email to <u>dean@niperhajipur.ac.in</u> and <u>registrar@niperhajipur.ac.in</u> indicating their research area/respective department. Soft copies of certificates supporting the date of birth, educational qualifications, reservation category (if applicable) and fellowship examination must also be sent along with the CV.

- The suitable candidates will be called for an interview (Online/offline) at NIPER-Hajipur.

## **Process of NIPER-Hajipur PhD Admission**

- The names of the successful candidates eligible to join the NIPER-Hajipur PhD program will be declared who are then required to join NIPER-Hajipur.
- The admission is subject to the verification of all documents defining eligibility. Being an ineligible candidate will cancel the candidature at any stage of the admission process.
- Successful candidate need to pay PhD admission fee as described in NIPER-JEE 2024 admission brochure.
- NIPER Hajipur will not pay any fellowship to the direct PhD admission/independent fellowship admission at any circumstances.

- Matriculation Certificate as a proof of age and correct name.
- Mark sheets of all the semesters' years of qualifying degree
- Original Migration Certificate (Last University/ Institute Attended)
- GPAT/GATE/NET Card wherever applicable.
- Award letter (if any) of NET-JRF of CSIR/UGC/DBT/ICMR, DST etc.
- Caste certificate, if applicable.
- Certificate of disability, if applicable.
