Applications are invited to recruit a Temporary Staff Nurse at the National Institute of Pharmaceutical Education and Research (NIPER), Hajipur. The post is offered on a temporary basis and does not confer any right to claim subsequent employment or a permanent position in the future. The initial tenure of the contract appointment is six (6) months only. The tenure of the appointment may be extended subject to the satisfactory performance of the candidate and the necessity for continued retention. Terms and Conditions:

1. The appointment is purely temporary. The post is for a period of 6 months only. The tenure of the appointment may be extended subject to the satisfactory performance of the candidate and the necessity for continued retention.
2. The incumbent shall work under the direct supervision of the Medical Officer of the Institute and shall be responsible for out-patient nursing care, administration of medication as prescribed, intravenous cannulation and infusion monitoring, dressings and minor procedure assistance, recording of vital parameters, custody and stock control of drugs and emergency consumables, sterilization, infection control and biomedical waste management.
3. They shall be entitled to leave as per the Institute norms applicable to contractual staff, and shall not be allowed any leave without the permission of the competent authority.
4. He/she should undertake whatever other tasks that may arise in order to contribute to the functioning of the Medical Centre and the Institute.
5. They should follow the rules and regulations laid down by the Institute administration from time to time.
6. They should adhere to the ethics and etiquette of medical practice, maintain confidentiality of patient information, and maintain the dignity and decorum of the Institute.
7. Preference will be given to experienced candidates.

Selection Criteria: (Certificate Verification & Personal Interview)

General Instructions:

1. The applicants should go through all instructions carefully and ensure that the applicant fulfils all eligibility conditions. Their admission to all stages of the recruitment will be purely provisional, subject to satisfying the eligibility conditions.
2. Candidates should carefully fill out all the details required in the application form, including age, educational qualification, nursing council registration, experience and details of valid Community/PwD certificates, as no correspondence regarding change of details will be entertained after the last date for applying. If any of their claims is found to be incorrect, it will lead to rejection of their candidature.
3. The application, duly filled in and signed, together with **self-attested copies of all supporting documents, must be scanned and sent as a SINGLE PDF file by e-mail to registrar@niperhajipur.ac.in with a copy to mo@niperhajipur.ac.in**. The subject line must read **“Application for the post of Temporary Staff Nurse”**. No hard copy is required to be sent by post.
4. The Institute shall not be responsible for non-receipt of an application on account of an incorrect e-mail address, oversized attachment or delivery failure. An acknowledgement of receipt shall not be issued individually.
5. The prescribed essential qualifications indicated are the bare minimum, and mere possession of the same will not entitle the candidate to be called for the selection process.
6. The Institute reserves the right to restrict the number of candidates called for the selection process to a reasonable limit based on qualifications, level and relevance of experience higher than the minimum prescribed in the advertisement, and other achievements. The Institute has the right to decide the mode of screening and testing of the applicant for shortlisting and selection.
7. The number of vacancies indicated in this notification is tentative. The Institute reserves the right not to fill any or all posts advertised and to reject any or all applications without assigning any reason.
8. Candidates shall have to produce original documents, together with the signed hard copy of the application, at the time of appearing for the selection process.

9. The qualification prescribed should have been obtained from a recognized University/Institution.
10. No TA/DA shall be paid to the candidates attending the selection process.
11. Any dispute with regard to the selection process will be subject to the court/tribunal having jurisdiction over Hajipur, Vaishali, Bihar.
